

LEGAL TERMS AND CONDITIONS FOR THE IBERCON TICKET RAFFLE

The "**Asociación para la Cultura Furry Española**" (hereinafter, "the Organization"), with CIF **G1947183**, organizes a Raffle (hereinafter, "the Raffle") subject to the following legal terms and conditions:

1. TERRITORIAL SCOPE AND APPLICATION

The Raffle will take place within the territory of the European Union and the United Kingdom and is open to individuals over 18 years of age who meet the requirements set forth in these terms and conditions.

2. DATES OF THE RAFFLE

- **Start of the Raffle:** December 16, 2024.
- **End of the Raffle:** December 26, 2024, at 11:59 PM.
- **Winner selection date:** December 27, 2024.

3. ELIGIBILITY REQUIREMENTS

Any individual meeting the following criteria may participate in the Raffle:

- Reside in a country within the European Union or the United Kingdom.
- Be over 18 years of age.
- Is not a member of the staff or a volunteer for the Organization.
- Perform the following actions during the Raffle period:
 1. Follow the Organization's official Telegram channel: <https://t.me/IberconOficial>
 2. Repost the official Raffle post on X (former Twitter).
 3. Share the official Raffle post on BlueSky.

4. FREE PARTICIPATION

Participation in this Raffle is completely free and does not involve any cost to the participants.

5. PRIZE

The prize consists of:

- One free ticket for IBERCON 2025, which is the ongoing furry convention organized by the Association, and with the value of said ticket currently set at 180€.
- The prize does not include expenses with transportation, accommodation, or any other costs associated with attending the event.

Important note: If the winner has already purchased a ticket to the convention, they may choose to upgrade their ticket to the matching tier of the Raffle ticket, and their former ticket can be granted to another person of their choice. They may simply transfer the prize to another person of their choice if they so desire or if their ticket matches it in value. The

transfer process must be communicated to the Organization via email at soporte@ibercon.org.

6. WINNER SELECTION

The winner will be selected through a random selection system using a reliable and transparent tool, such as (but not limited to) Sortea2.

The Organization will contact the winner via private message on the social media platforms used for their participation. If the former winner does not respond within 48 hours, another participant will be selected as the winner.

7. ANNOUNCEMENT OF THE WINNER

The name or username of the winner will be published on the Organization's social media platforms (X, BlueSky, and Telegram) on December the 27th, of 2024.

8. PROCESSING OF PERSONAL DATA

In accordance with the General Data Protection Regulation (GDPR) and the Organic Law on Data Protection and Guarantee of Digital Rights (LOPDGDD), participants are informed that:

- Personal data collected (social media usernames, etc.) will be used exclusively for the management of the Raffle.
- The data controller is the Organization.
- Participants may exercise their rights of access, rectification, erasure, and objection by writing to soporte@ibercon.org.

9. ACCEPTANCE OF THE LEGAL TERMS AND CONDITIONS

Participation in the Raffle implies full acceptance of these legal terms and conditions. Any failure to comply with them by a participant will result in their exclusion from the Raffle.

10. MODIFICATIONS AND DISCLAIMER OF LIABILITY

The Organization reserves the right to modify these terms and conditions, as well as to cancel or suspend the Raffle if necessary due to greater force and/or unexpected circumstances. Any modification will be communicated to the participants.
